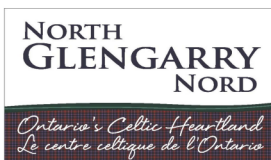

Employee highlight

Jacob Rheaume

Director of Building, By-Law & Planning/CBO

Jacob began working in the world of construction at the young age of 13 years old, when he began working for a family-run building and supply business in St-Albert. Originally from Ottawa, Jacob moved to St-Albert as a young child and had since fallen in love with cheese curds and has refused to relocate. Throughout his time there he worked in the lumber yard, on job sites as a labourer and finally in the office in sales and as an architectural designer.

He studied for 3 years at La Cite Collegial in order to receive his diploma as an Architectural Technologist. Shortly after completing his schooling he began teaching a few courses on construction methods and materials at La Cite, and did that part-time for about 10 years. He then became a Building Inspector for the Township of North Stormont for about 5 years, before joining the team here in North Glengarry, and has been here for about 6 years.

He wants to remind residents that it is important to ask questions, Jacob and his team welcome a lot of questions. Many issues tend to arise from lack of communication and he states that it is always easiest to answer a question ahead of time before trying to resolve the issue later.

Jacob's favourite part of being a building official is



seeing the translation from building code requirements to numbers and calculations and finally to seeing the actual construction process progress.

He is hoping to start travelling a bit more this summer and spend more time with family and friends as the regulations allow.

Individuals Booked for a Second Dose on or After August 28 Must Reschedule to an Earlier Date

The Eastern Ontario Health Unit (EOHU) is informing the public that mass COVID-19 vaccination clinics are expected to conclude by August 27, 2021. As a result, over 16,000 individuals will need to bump up their second dose appointments.

Thanks to ample vaccine supply and accelerated second dose appointments for all individuals aged 12 years and older, there will no longer be a need for mass clinics beyond August 27, 2021.

Re-booking is available at [Ontario.ca/bookvaccine](https://ontario.ca/bookvaccine). Individuals who require assistance with booking can call the Provincial Vaccine Booking Line at 1-833-943-3900. For questions, call 1-888-999-6488. A minimum of 28 days must pass between the first and second vaccine if you had Pfizer or Moderna for your first dose, or 8 weeks if you had AstraZeneca. Small Business Health and Safety Training Program

The Ontario government is investing \$10.5 million to provide up to 60,000 small businesses across the province with free health and safety training over the next three years.

The new Small Business Health and Safety Training Program will improve health and safety awareness to help prevent illness and injuries by training health and safety representatives of small businesses on how to keep workers safe in retail, construction, health care, accommodation, and food services as well as many other sectors. Businesses will also be reimbursed for the time the representatives are away from work.

Ontario Helping Small Businesses Establish Online Presence

The Ontario government is investing \$10 million towards the Digital Main Street program for 2021-22 to help over 13,000 small businesses expand their digital presence and market their services online. As businesses enter Step 3 of the Roadmap to Reopen, the renewed program will provide small businesses with \$2,500 grants, technical training, and digital resources to help them reach more customers in person and online, positioning them for a stronger recovery.

Beyond the grants, Digital Main Street, a partnership between the Ontario and federal governments, equips businesses with ShopHere support for opening online stores and access to Digital Service Squads offering one-on-one help.

Small businesses with a brick-and-mortar location and one to 50 employees, including those in shopping malls, can apply for Digital Transformation Grants on the Digital Main Street portal. For more information please click [HERE](#).

Community support

Support for Agricultural and Horticultural Societies

The Ontario government is providing \$1.1 million in additional funding to offer continued support for the province's agricultural and horticultural societies impacted by COVID-19.

The government will provide up to \$5,000 for each eligible agricultural society and up to \$1,500 for each eligible horticultural society, equal to their 2019 grants.

Ontario Supporting the Wine Agri-Tourism Sector

The Ontario government is launching a new Winery Agri-Tourism COVID-19 Relief Initiative to support agri-tourism businesses impacted by the COVID-19 pandemic. Ontario wineries and cideries with on-site stores whose business were impacted by COVID-19 safety measures to stop the spread of the virus will be eligible for this one-time grant.

Businesses that saw a revenue decline in at least one area of their operations, such as decreased tourism, tours, events and tastings, or have faced increased expenses to comply with public health safety measures for COVID-19 will be eligible to receive support.

Through the grant, eligible wineries and cideries will receive a one-time payment based on their sales of wine and cider in 2020-2021 in their on-site winery retail store. Click [HERE](#) for more information on the program.

Working in the Heat

When is hot too hot?

Legislation is not always specific about the acceptable range for temperature conditions at work, especially when working outdoors. In some cases, for specific circumstances, the Threshold Limit Values for heat stress from the American Conference of Governmental Industrial Hygienists have been formally adopted as occupational exposure limits in some jurisdictions, while others use them as guidelines.

Employers can take measures to protect workers from heat stress disorders by avoiding heavy exertion tasks, extreme heat, sun exposure, and high humidity when possible.

Provide plenty of water.
Workers should drink a cup every 15 to 20 minutes, thirsty or not, and avoid caffeine and alcohol.

Provide breaks to rest and cool off, preferably in a cool area, in the shade or in air-conditioned buildings or vehicles.

Set up shade structures.
Umbrellas, buildings, and trees can also shield workers from the rays of the sun. Note: you can still get sunburn on a cloudy day.

Make sure outdoor workers wear light, loose-fitting clothing, UV-rated sunglasses and a wide-brim hat. Provide sunscreen with a sun protection factor (SPF) of at least 30 and UVA/UVB protection, and allow workers to re-apply every 2 hours and after sweating.

Gradually increase work load and heat exposure to give workers time to adjust to working in the heat.

Schedule less strenuous tasks between 11am-4pm when the sun's rays are strongest.

Protective clothing or personal protective equipment may increase heat retention. Be sure to plan work and breaks accordingly.

Provide education and training about heat-related illnesses. People are generally unable to notice their own heat stress-related symptoms and depend on their co-worker's ability to recognize these symptoms and seek timely first aid and medical help.

As the temperature or heat burden increases, workers may feel:

- Increased irritability
- Loss of concentration and ability to do mental tasks
- Loss of ability to do skilled tasks or heavy work

heat exhaustion

- nausea
- headache
- heavy sweating
- cold, pale, moist skin
- dizziness
- muscle cramps
- weakness
- fatigue

heat stroke

- nausea
- hot, dry skin
- loss of consciousness
- confusion
- strange behaviour
- high body temperature
- headache

Move to a cooler, shaded location.

Remove as much clothing as possible (including socks and shoes).

Cool down by applying cool wet cloths or ice to the head, face or neck. Spray with cool water.

Drink water, clear juice or a sports drink.

Provide medical aid if the person does not start to feel better.

Stay with the person until help arrives.

Call 911 immediately
This is a medical emergency. Stay with the person until help arrives.
